COURSE OUTLINE - ESTHETICS 900 HOURS

COURSE TITLE

Esthetics

This course is 200 hours longer than the minimum standards required by the State of Indiana. This school has chosen to add 200 hours to the minimum standard to enhance the minimum curriculum, required by the State of Indiana. The additional subjects include, but are not limited to essential oils, advanced massage, advanced skin modalities, micro blading, chemical treatments, and spa studies. The job descriptions required by the employer are more demanding than what is required in a basic 700-hour program.

This course includes free employment assistance and includes but is not limited to classes/Career Path in professionalism, resume development, interview preparation, and job search skills.

COURSE DESCRIPTION

This course is divided into two levels of study. The **freshman level**, **o** – **450 hours**, presents introductory lessons and skills to the learner. At this level, the student will learn the basics skills of client charting, skin analysis, cleansing, massage, and machine activity. The **second level**, **450-900 hours**, allows the learner to practice those skills in the lab that were acquired during the freshman level of study. It will also include those theories and lab activities inclusive of advanced spa services. This area of study will include, but not be limited to micro-dermabrasion, hot stone therapies, and body work. This is the area of study in the lab that allows the learner the opportunity to practice both basic and multiple advanced methodologies. All levels of training provide theory lectures/demonstrations.

COURSE OBJECTIVES/GOALS

The goal of the esthetics course is to provide the learner with the opportunity to obtain their esthetic license and to enter the job market with entry level skills.

PROJECTS/ASSIGNMENTS

The student must complete the Indiana Progress Book and any independent assignments given during classroom activity.

The student's progress during each of the two levels of training is evaluated quantitatively. The following is a list of required MINIMUM assignments.

EVALUATION/GRADING

Theory exams are given weekly. Practical evaluations are given periodically throughout the course.

A cumulative score composed of attendance, weekly theory exams, quantitative assignment completion and applicable practical evaluations are used to determine satisfactory progress through out the course. A minimum standard of 80% is required.

GRADUATION EVALUATION

All assignments, projects, tests, and hours must be completed before the student is eligible for graduation. School finals completed with a minimum score of 80% enable the student to file for their licensing exam.

ATTENDANCE

The maximum time frame for course completion is 150%. To complete the course within the contractual obligations, the student must attend class 90% of the time. Students will be billed for hours/work required beyond the terms of their enrollment contract.
